Schedule of Fees

Being a By-Law to amend By-Law # B-2011-82 of the Timmins Police Services Board respecting a schedule of fees for the Timmins Police Service.

Whereas the Timmins Police Services Board is responsible for the provision of adequate and effective police services, and that the members of the police service, through the Chief of Police, are subject to the government of the Board and shall obey its lawful direction; and

Whereas the Timmins Police Services Board recognizes the need to establish a schedule of fees to provide adequate service and allow for cost recovery;

Now therefore be it resolved that the Timmins Police Services Board enacts the following:

That By-Law # B-2011-82 be rescinded, and that the fees applicable for the Timmins Police Service shall be as set out in Schedule "A" of this By-Law.

That this By-Law come into force and effect on June 26, 2014.
